

## Decision-making tool for national implementation of the Plant Treaty's multilateral system of access and benefit-sharing

**Project Title:** P66 - Global policy support for biologically diverse, climate resilient agriculture

**Description of the innovation:** The decision making tool is designed to assist policy actors to identify appropriate measures to implement the Plant Treaty's multilateral system of access and benefit-sharing. The decision-making tool is divided into the eleven sections corresponding to issues that national-level policy actors need to address. Each section includes draft 'baseline' legal provisions related to each option; these can be adapted/incorporated into new laws and administrative guidelines.

Final revised version was published in 3 languages in 2018.
